Negotiations

OLD BUSINESS:

AMBA:

The decision to move forward with AMBA was tabled at the December meeting.

Ronnie spoke about the issue of AMBA and being in favor of the GCEA moving forward with all AMBA has to offer including rebuilding of our website.

Jaime spoke to the conflict of interest and is not in favor of moving forward with AMBA. Membership would have to forfeit their benefits with Aflac, Principal Life, Nationwide Pet, Legal Shield within the first year. The members would no longer have the benefit to have these items deducted from payroll. All benefits would become private pay.

James Fagen, CEA spoke regarding AMBA contract. If the board moves forward with AMBA there will be some issues with contract language that will need to be resolved. One issue is with data collection. AMBA laws are based out of Travis County, Texas and not California.

Iris Moreno Hernandez spoke regarding the issue and stated that going with AMBA would cause the membership to forfeit benefits with our current vendors. She stated that rebuilding our website should be moved up as a priority and was willing to help vet a vendor.

Maurice Daniels made the motion to stay with our current vendors and not move forward with AMBA. Bertha Albright seconded the motion.

- The majority of members voted in favor of the motion to not move forward with AMBA.
- 16 members voted in favor of the motion; 1 voted against the motion; 3 members abstained.

NEW BUSINESS:

James Fagen addressed the new marijuana law in the state of California. The law has exceptions except for DOT, Public Safety and Building and Trades classifications. According to the new bill you cannot be penalized if there are non-psycho actives in your system."

Jaime, Ronnie, and James would like to see a designated Disciplinary Committee that would handle all situations after the initial director meeting. This needs to be a larger committee that is committed to helping members and not just Ronnie and Jaime. If you are interested in serving contact Jaime, Ronnie, or Stephanie.
